# Consent form for the use of images and videos

#### CONSENT FORM FOR THE USE OF IMAGES AND VIDEOS

Dear parents/legal representatives,

In the European School Frankfurt we have the opportunity to take photographs and make video recording of our pupils while they participate to a wide range of schools events and activities (i.e.; school trips, newsletter/gazette, yearbook).

In order to respect the privacy of your child(ren) and to be compliant with data protection legislation (the General Data Protection Regulation and associated national legislation), we are legally obliged to obtain your prior authorization to take photographs and make video recordings of your child(ren) during the school year.

As you probably know, the School has around 1525 pupils and it is very difficult to exclude children from group shots being taken during school activities such as theater play, band performances, school trips, etc. Although children like to be included and their families like to see them during the school activities, we will respect your choice if you wish that your child should not to be photographed or filmed.

Therefore and in the interest of an efficient and transparent administration, we need every parent/legal representative to complete and return this consent form to the school. If your child has reached the age of majority, he or she must complete and return the present consent form.

In case we do not receive authorization, we will have to exclude your child(ren) from photos and video recordings at school. For instance, we will have to ask the band members who did not return the consent form to step out of photos/videos being taken at performances, the same for children participating to school trips or to the winner of a prize if a photograph of the team is being taken by the teacher.

These explanations are for the parents/legal representatives to understand why the School has to request consent and what are the practical measures the School will have to implement to comply with its legal obligations.

We would appreciate if you could complete and return this form by 10.04.2019.

The photographs used for temporary publications (newsletter/gazette/magazine, yearbook) will be erased after the publication.

Photographs that do not identify pupils and class group photographs will be safely and indefinitely retained for historical purposes.

In the event that photographs need to be taken or video recordings need to be made during situations that are not covered by this consent form, we will contact you for permission.
